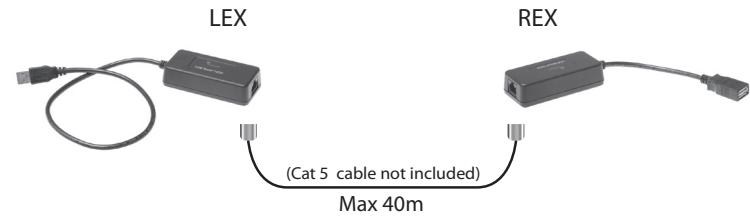

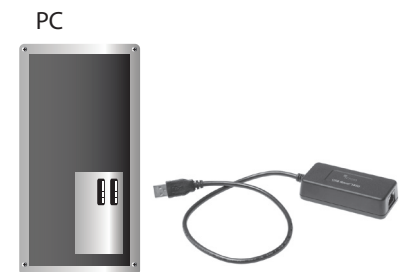

Before you get started, ensure that all the drivers required for your USB device(s) are installed.

- 1 Place units where desired, and connect the Cat 5 (solid core) extension link cabling to the Link ports (RJ45) on the LEX and REX units.



- 2 Connect LEX unit to PC.



- 3 Attach USB device to REX unit.
